- Each work is labelled with a lot number, artist, title, description and a condition report. Each work is given a guide 'retail price' which is for your information only. The 'reserve price' is the lowest bid that may be accepted for the work. If a work has no reserve price then there is no lower limit to bids that may be accepted for the piece.
- To make a bid for any of the lots, you need to click the 'Place Bid' button to the side of the picture you've selected. In the form that appears please make sure that you fill out your email and phone number so that we can reach you after the auction has ended if you are successful in your bid. Then in the 'message' box please clearly state what bid you would like to make for the artwork (e.g. "I would like to bid £500 for this work".)
- There is no limit to the number of bids you may submit. Multiple bids for an individual lot are acceptable if you decide to raise your bid.
- There will be no additional charges added to the cost of each sale. The successful bid is the final price due for the lot. Where applicable, VAT, Artist's Resale Right, and framing costs are included in the retail / reserve price as the artwork is displayed at the auction.
- The deadline for all bids is 9pm on Sunday 8th December 2024 via www.eamesfineart.com.
- If you have any trouble placing a bid or need to ask any questions about a lot or the bidding process you can reach us on 0207 407 6561 during usual opening hours.
- Bids may also be placed in person at Eames Fine Art Studio from Friday 6th to Sunday 8th December 2024.
- Eames Fine Art will collate all bids immediately after the auction, and winning bidders will be contacted by 6pm on Tuesday 10th December. Please ensure that you can be reached on the contact number / email address you provide.
- Payment of winning bids is due within five working days by cheque, credit/debit card, bank transfer or cash. Artworks will not be released until funds have cleared.
- Once an online form is submitted it forms a written contract between the signatory and Eames Fine Art Ltd to purchase the named artwork at the stated price if this is the highest bid received for the lot.
- In the event of a tied bid, both bidders will be contacted on Monday 9th December and given the opportunity to raise their
